Based on the proven and certified SAP add-on named SKY Billing, this solution offers full-size L functionality plus SAP SD integration.

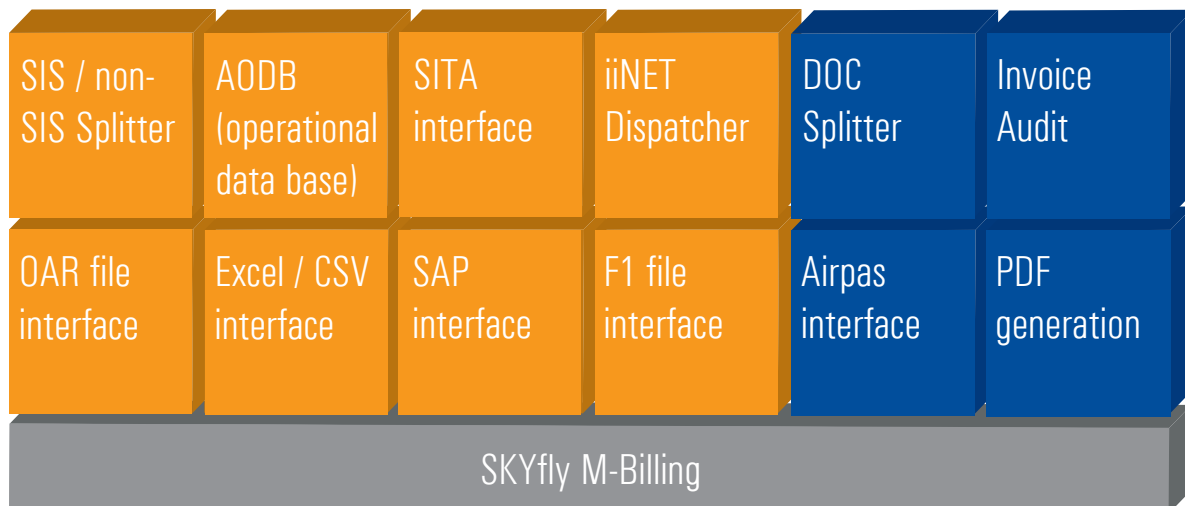

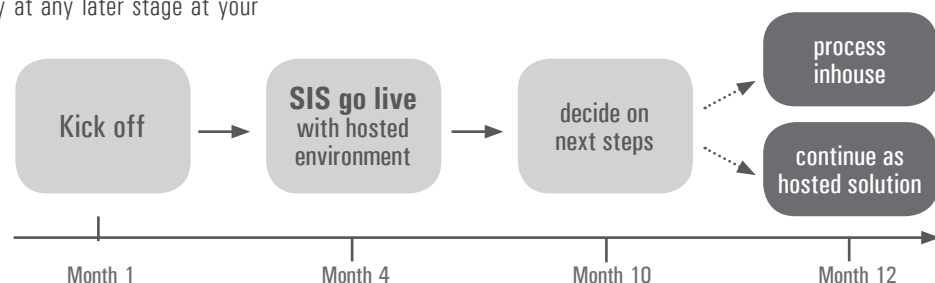
